RESULTS OF BUSINESS DISCUSSION AT LAST MEETING:

- Issue 1: Move annual dinner to avoid bad weather. PASSED. Date chosen was early/mid March. Annual competition will end in Dec as usual.
- Issue 2: Change format to less formal/less expensive. PASSED. Still need to decide on location. Options offered were pot luck at Baptist church (no booze) or Fort Wright Civic Center (maybe booze), either no cost.
- Issue 3: Change manner in which annual recognition is given (Award giving takes too long.) Numerous suggestions final motion was; same format as before but no judge comments PASSED.
- Issue 4: Change club year end date. Discussion revealed the club wanted to keep end of year as the end of the year. No vote taken, no change to by laws needed.
- Issue 5: Slate of Officers. Various suggestions offered but two were discussed in depth; judges should have office for two years and we should have 3 judges for each category rather than two. No motions could be agreed upon in the time allowed. Issue tabled.
- Issue 6: How to incorporate digital photography into the club's format. Numerous suggestions offered. No consensus could be reached in the time allowed. Issue tabled.
